Huli'tun Health Society (HHS) has an immediate opportunity for **one** position: a 1.0 Home Care Nurse (HCN) with an option to work .8. At times, the incumbent may require a flexible schedule to support Events, Staff training, and Meetings. The Home Care Nurse will have other internal medical support, which includes but is not limited to collaborating closely with a Nurse Practitioner, Licensed Practical Nurse/ Health Coach, Pharmacist, Home Care Representatives, HHS Community Health Nurse, and HHC Home Care Aide.

PRIMARY RESPONSIBILITIES

Working within the HHS 5 Year Health Plan, the HCN will be required to work both in the office and make regular home visits to deliver direct nursing care, guiding, and supporting members, as well as regular ongoing patient charting on the EMR. The HCN completes a structured patient assessment that includes advocacy, ongoing reassessment and determines patient need and service allocation, while developing a patient-centered care plan. The HCN will also advocate and provide nursing care and teaching strategies to assist patients/families dealing with chronic illness. HCN is to establish an internal and external connection with accreditation, other professionals, and community resources. Collaborates and communicates with the Health Director regularly to keep them aware of health needs that are vital in community and to focus on communicable disease and to support implementing required services to our member nations.

QUALIFICATIONS

- Bachelor of Science in Nursing and current practicing registration with the College of Registered Nurses of BC
- Immunization certification through BCCDC.
- Minimum of three years' experience as a Home Care Nurse, with recent and/or diverse acute care nursing, or equivalent.
- Cultural safety and humility; ability to provide culturally appropriate nursing care and patient education with a focus on health promotion and disease prevention.
- Experience working in a First Nations Community is essential, and a willingness to learn about the culture, customs and traditions of the Lyackson First Nation and Halalt First Nation people.
- Operational knowledge of the programs and services of First Nations Health Authority, Federal and Provincial Health programs and services (FNHA & Island Health), Indigenous Services Canada programs, Ministry of Children and Families (MCFD & other Child and Family agencies).
- Teamwork with HHC employees and within programs and events.
- Budgeting, inventory, and day-to-day operations for the department.
- Ability to take initiative, work independently, and with limited supervision.
- Criminal Record Check with vulnerable sector check is required.
- Valid class 5 BC driver's license with reliable vehicle and satisfactory driver's abstract.
- Experience with Accreditation Canada is an asset.
- Foot Care Basic and Advanced training is an asset.
